Since the announcement that the UK would leave the European Union and adopt its own version of REACH, industry has been voicing its concerns as to the potential impact of the existing UK REACH system.

One of the main aspects communicated was the duplication of effort and financial burden facing UK businesses along with the potential loss of substances.

After months of discussions between industry, regulators and Trade Associations, the Secretary of State for the Environment announced in December 2021 that *“Defra has committed to exploring alternative arrangements for UK REACH transitional registrations in order to support chemical businesses whilst upholding the highest standards to safeguard public health and the environment.”*

Discussions are on-going but as aspects become clearer the Chemical Business Association is committed to sharing the progress of this important development in critical regulative instrument.

The workshop will also review the lessons learned so far in relation to changing suppliers, introducing new substances and updating your DUIN submission.

The workshop provides an update as to the current ‘state of play’ of the UK REACH ‘New Approach’ negotiations. It will focus on the following topics:

- **Potential registration deadline extension proposals**
- **Registration process lessons learned so far**
